29 That none of said streets have been opened to the public use nor are they now being used  
 30 by the public nor is there any possibility of their being used by the public in the future, and that

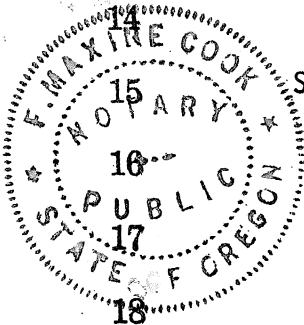
