WHEREAS, Union County finds all or parts of several County Roads entirely within La Grande city limits;

WHEREAS, ORS 373.270 establishes the procedures for transferring jurisdiction over county roads within cities;

WHEREAS, public notice was published in "The Observer" on February 13, 20, 27 and March 6, 1990, advertising a public hearing on March 7, 1990, 10:00 a.m., Joseph Building East, Conference Room;

NOW THEREFORE, BE IT ORDAINED BY THE COURT OF THE COUNTY OF UNION, STATE OF OREGON:

SECTION 1: TRANSFERRING JURISDICTION OF ELEVEN COUNTY ROADS TO THE CITY OF LA GRANDE


The Union County Court hereby offers to the City of La Grande to surrender jurisdiction over the following County roads or portions thereof:

- .12th Street - Cemetery south across Gekeler Lane to Taurus Avenue.
- .Gekeler Lane - 12th Street east to Oregon Highway 203.
- .18th Street (Grand View) - Gekeler Lane south 184 feet.
- .21th Street (Wall Street) - East "L" Avenue south to East "M" Avenue.
- .North Hall Street (Hall Street) - East "L" Ave. north to Cove Ave.
- .East "L" Ave. (East "M" Ave.) - Willow Street east to 25th Street.
- .25th Street - Cove Avenue south to East "L" Avenue.
- .Progress Loop - Cove Avenue.
- .Cove Avenue - North Willow Street east across I-84 to city limits.
- .26th Street (Holmes Road) - Oregon Highway 82 south to Cove Avenue.
- .East "Q" Avenue (Poplar) east of 26th Street.


SECTION 2: TIME FOR ACCEPTANCE


