WHEREAS, Union County Court, through a "Joint Management Agreement" between the City of La Grande and Union County, Oregon, gave administrative authority to the City of La Grande to develop a street addressing and street naming ordinance within La Grande's Urban Growth Area;

WHEREAS, a public notice was published in "The Observer" on March 16, 1990, for a public hearing to be held in the Joseph Building Annex, Conference Room, April 4, 1990, 10:15 a.m.;

WHEREAS, revisions to address' and street names within this area should be developed according to city standards;

WHEREAS, maintenance of an addressing system should be performed to city standards;

NOW THEREFORE, BE IT ORDAINED BY THE COURT OF THE COUNTY OF UNION, STATE OF OREGON:

SECTION 1: ADOPTING ROAD NAMES WITHIN THE URBAN GROWTH BOUNDARY OF LA GRANDE

The Union County Court hereby adopts the "Union County Street Name Changes Within the Urban Growth Area, ~~March~~ April, 1990" which is a part of and affixed to this ordinance.

UNION COUNTY STREET NAME CHANGES
WITHIN THE LA GRANDE URBAN GROWTH AREA

Section 1: That the following public streets, private easements and County roads between the La Grande Urban Growth Boundary and the city limits of the City of La Grande, Oregon, be and are hereby changed as provided in Section 3 of this Ordinance, and that hereafter the same shall be called and known by the name as provided in said section.

Section 2:

- A. That the county road(s) commonly known as May Park Road, May Street and Frontage Road, beginning approximately 950 feet west of North Spruce Street and continuing easterly to Riddle Road, be changed to and known as May Lane;
- B. That the public usage road commonly known as Watson Street, beginning at May Lane and continuing south to the northerly right-of-way of Interstate Highway 84, shall be known as Watson Street;
- C. That the private easement approximately 300 feet south of May Lane and beginning on the west right-of-way of Watson Street, thence west approximately 600 feet, shall be known as Michaelson Lane;
- D. That the private easement beginning 450 feet west of the intersection of May Lane and Riddle Road, thence south approximately 530 feet from the south right-of-way of May Lane; thence easterly to the west right-of-way of Riddle Road, shall be known as Bearco Loop;
- E. That the private road easement as recorded on the Otten Subdivision plat shall be known as Otten Drive;
- F. That the private easement beginning 2800 feet south of the intersection of Gekeler Lane and 12th Street; thence westerly approximately 1000 feet from the west right-of-way of 12th Street and commonly known as Gildcrest Drive, shall be known as Gildcrest Drive;
- G. That the county road commonly known as Bushnell Road, beginning approximately 440 feet south of the intersection of Gekeler Lane and 12th Street thence south approximately 3080 feet to the southwestern boundary of the City of La Grande's Urban Growth Boundary, be changed to and known as South 12th Street;

- H. That the private easement beginning on the west right-of-way of Modelaire Drive with its intersection of Hawthorne Drive, thence southwesterly approximately 2000 feet, shall be known as West Hawthorne Drive;
 - I. That County Road Number 23 (McAnish Avenue) beginning on the south right-of-way of Gekeler Lane with its intersection of 20th Street, thence south approximately 1304 feet, be changed to and known as South 20th Street;
 - J. That Grand View Avenue, beginning at a point approximately 190 feet south of the south right-of-way of Gekeler Lane with its intersection of 18th Street, which is the south city limits of La Grande; thence south approximately 1210 feet, be changed to and known as South 18th Street;
 - K. That the county road on the south side of Grand View Addition extending from the present Grand View Avenue to the present County Road Number 23 (McAnish Avenue), be changed to and known as Grand View Avenue;
 - L. That the county road beginning on the east right-of-way of Second Street with its intersection of Miller Drive, thence easterly along the south city limits of La Grande to the northeast corner of Section 18 of Township 3 South, Range 38 EWM, thence south approximately 554 feet, be changed to and known as Miller Drive;
 - M. That the county road commonly known as North Spruce Street or Mt. Glenn Road, beginning at the north city limits of La Grande at Interstate Highway 84, thence north to the south end of the bridge crossing the Grande Ronde River, shall be known as North Spruce Street;
 - N. That the county road beginning at the intersection of North Second Street and Lake Avenue; thence northwesterly to North Cedar Street, shall be known as North Second Street;
 - O. That Highway 30, or Orodell Boulevard, from the west city limits of La Grande to the Interstate Highway 84 interchange be changed to and known as Adams Avenue.
