WHEREAS, Court Order 2006-09, In the Matter of Proceeding with the Starr Lane LID (Local Improvement District), adopted on March 15, 2006 authorized the County Public Works Department to proceed with implementation of Starr Lane LID;

WHEREAS, the County Public Works Department completed preparation and three lifts of chip seal on three-quarters of a mile on the west end of Starr Lane in 2006 and two additional chip seal lifts in 2007;

WHEREAS, Oregon Revised Statutes and Union County Ordinance No. 1988-7 Special Assessment Ordinance direct how financial reimbursement payments from affected property owners will be completed;

WHEREAS, all affected property owners were mailed notice on November 13, 2007, notifying them of a Board of Commissioners public hearing on November 28, 2007, notifying them of the amount owed and notifying them of the opportunity to make installment payments.


SECTION 1: STARR LANE LID ASSESSMENT

SECTION 2: STARR LANE LID PAYMENT OPTIONS

Each Starr Lane LID property owner is permitted to make payment in full within 30 days of this Order's adoption without interest, however unpaid assessments after 30 days will be assessed an additional 8% annual interest and \$32 recording fee for the cost of filing a property lien in the amount of the outstanding assessment and ultimate filing of a Satisfaction of Local Improvement Lien.


