And it appearing to the Court that said petition is signed by more than twelve free holders of this County, residing in the road district where the hereinbefore described road is proposed to be, and it satisfactorily appearing to the Court that notice has been given by advertisement for more than 30 days immediately prior to the presentation of said petition to this Court, notifying all persons concerned that application would be made to this Court at the present session of this Court and that the notices so posted were in due form and duly signed by the petitioners and that a bond in the sum of \$100.00 for the Cost of this proceeding has been given and is approved by this Court,

IT IS THEREFORE ORDERED that Arthur Curtis, County Surveyor and B. Logsdon and E.B. Morelock constituting the Board of County Road Viewers, be and they are hereby directed to meet at the beginning of said proposed road on the 22nd day of September, 1905, or within five days thereafter, and proceed to survey, view and lay out said road according to law.
