unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:  
**all our right title and interest in and to a strip of land forty(40)  
feet wide beginning at a point seventy six(76) rods north east of the  
south east corner of the north east quarter of the south west quarter  
of Section 33 Township 5 South of Range 40 E.W. N., running thence  
in a general westerly direction in Sections 31,32,and 33, Township 5  
South of Range 40,E.W.M. and Sections 5 and 6 Township 6 South of Range  
40 E.W.M. and terminating at a point twenty one (21) rods east and  
thirty (30) rods north of the south west corner of the south east quarter  
of Section 31 Township 5 South of Range 40 E.W.M. a more particular  
description of said strip of land being shown by the surveyors plat of  
the proposed road ptitioned for by M.G.Church,et.,al.,on file in the
