This Indenture, WITNESSETH, That P. C. Wright

and Bessie Wright his wife, for the consideration of

One Dollar and other valuable consideration Dollars

to him paid, have bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

~~all our right title and interest in and to a strip of land forty(40) wide, beginning at a point seventy six(76) rods northeast of the south east corner of the northeast quarter of the south west quarter of Section 33, Township 5, South of Range 40 E.W.N. running thence in a general westerly direction in Sections 31, 32 and 33 Township 5 South of Range 40 E.W.N. and Sections 5 and 6, Township 6 South of range 40 E.W.N. and terminating at a point twenty one(21) rods east and thirty (30) rods north of the south west corner of the south east quarter of Section 31, Township 5 South of Range 40 E.W.N. a more particular description of said strip of land being shown by the surveyors plat of the proposed county road petitioned for by M.O. Church et., al., on file in the office of the County Clerk of Union County, Oregon, and to which plat reference is here made,~~

To Have and to Hold the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and we, the said Grantors

do hereby covenant to and with the said Union County that we have an equity in the owners in fee simple of said lands; that they are free from all encumbrances except mortgages for borrowed money known
