THIS INDENTURE WITNESSETH That Roscoe G. Marble
and Lessie Marble his wife, for the consideration of Three hundred Dollars,
to us paid, have bargained and sold, and by these presents do
bargain, sell and convey unto the County of Union, State of Oregon, the
following described land for road purposes to-wit:-

All that part of the property of Roscoe Marble in the southeast
quarter of the southwest quarter of Section 6, Township 1 North, Range
41, E.W.M. included in a strip 70 feet wide, being 35 feet in width on
each side of the center line of the Wallowa Hill Section of the La Grande
Joseph Highway as surveyed over and across said property and more particu-
larly described as follows;

Beginning at Station 1843 / 27, said station being approximately
1320 feet south and 810 feet east from the quarter section corner common to
Section 1, Township 1 North Range 40 E.W.M. and Section 6 Township 1
North Range 41, E.W.M. running thence in a general southeasterly direction
to Station 1882 / 14, said station being approximately 830 feet south and
1350 feet east from the quarter section corner common to Section 6 and 7,
Township 1 North Range 41, E.W.M. said parcel of land containing 6-25/100
acres more or less.

And the said grantor^s herein do hereby release and waive any
damages, if any, resulting to the lands owned by them immediately
adjoining either or both sides of the above described right of way from
slopes of cuts or fills extending beyond the limits of said right of way
and also any damage which may be sustained on account of rock or other
material rolling on to and across, or remaining on said lands during and
after the construction of said highway.
