THIS INDENTURE, WITNESSETH, That Mary T. Foley, a widow

to her paid, has she bargained and sold, and by these presents ~~do~~ bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property of Mary T. Foley, in the SE 1/4 of NW 1/4 of section 6, T 3 SR 38 EWM included in a strip of land 60 feet wide, being 30 feet in width ~~on~~ each side of the center line of the Oro Dell-La Grande section of the Old Oregon Trail as the same is now located over and across from the north side to the east side of said property, said center line being particularly described as follows:

Commencing at approximate station 343 - 00 of said line, at a point in the north line of the SE 1/4 of NW 1/4 of Section 6, T 3 SR 38 EWM approximately 442 feet west, as measured along said north line from the NE corner of said SE 1/4 of NW 1/4 of section 6; running thence south 28 deg 21' east 685.7 feet more or less, to station 349 - 85.7 of said survey; thence southerly on a 409.3 feet radius curve to the right 250.1 feet; thence southeasterly on a 409.3 feet radius curve to the left a distance of 334 feet, more or less, to approximate station 355 - 70 of said center line at a point in the east line of the SE 1/4 of NW 1/4 of section 6, T 3 SR 38 EWM, approximately 152.5 feet north, as measured along said east line from the SE corner of said SE 1/4 of NW 1/4 section 6. Said strip of land containing 1.75 acres, more or less.

TO HAVE AND TO HOLD the said land, with its appurtenances, for county road purposes to said Union County and the public therein forever, and I, the said Mary T. Foley, a widow do hereby covenant to and with the said Union County that I am the owner in fee simple of said lands; that they are free from all encumbrances except
