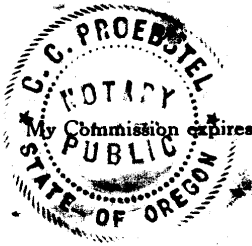

THIS INDENTURE, WITNESSETH, That Dewey Purcell

and Melissa Purcell his wife, for the consideration of One dollar (\$1.00) and no cents DOLLARS,

to them paid, has bargained and sold, and by these presents do bargain, sell and convey unto the County of Union, State of Oregon, the following described land for road purposes, to-wit:

All that part of the property located in the SW 1/4 of the NW 1/4 of Sec. 8, T 2S R39 E.W.M., and being more particularly described as follows:

Beginning at a point 102.0 ft., West and 20 ft., North of the SW corner of the SE 1/4 of the NW 1/4 of Section 8, T 2S R39 E.W.M., thence on a 82.3 ft., radius curve to the left a distance of 129.1 ft., thence North 1°12' East a distance of 1225.8 ft., thence South 89°05' East a distance of 20.0 ft., thence South 1°12' West a distance of 1307.8 ft., thence North 88°58' West a distance of 102.0 ft., to the point of beginning.

Said tract of land contains 0.65 acres, more or less.
