For at this time was presented a petition praying for the Vacation of a portion of a County road recently established and Running from LaGrande to Summerville. to Commence at "C" Street near the dwelling house of S. D. Poirerth thence north to the N.E. Corner of D. Chaplin's land thence East 20 Chains thence North to the point where the road leading from LaGrande to Summerville will intersect the same on W. H. Baker's East line also commencing at the South End of the Lane of Prosser's north to the Bluff James Baker Thos. Morris & Joseph Young were chosen as Viewers to meet at point of beginning on the 10<sup>th</sup> day of Feb 1864 at 9 O'clock A. M. D. Chaplin was appointed as Surveyor

In the matter of a proposed  
County Road

In accordance with a petition heretofore presented praying for the Establishment of a County Road commencing at the End of the Lane One and One half mile Westly from the town of Union & running nearly South thence Westly One half mile thence by the nearest and most practicable route to intersect the road leading over the Ladd Hill. the Court appointed Geo. Barlow, Wm. Reese and Joseph Cornell as Viewers to meet at the point of beginning to meet at 9 O'clock on the 15<sup>th</sup> inst. D. Chaplin was appointed as Surveyor

Report of  
Road Supervisors

The Report of Supervisor R. H. Mallory of Road Dist No One was received and accepted and also the Report of W. Barber Road Supervisor of Dist No 10 also the Report of A. Merrillgale Supervisor Road Dist No 11 and the Report of George Barlow Supervisor Road Dist No 9

Correct on further examination it is found that there is no bond filed and that notice has not been given at the time Required by law - the entry is therefore declared void

At a regular term of the County Commissioners Court of Union County Oregon began and held at the Court House in La Grande on the 9<sup>th</sup> day of March 1867 There was present Hon. J. Alberson County Judge, P. Morton Commissioner, A. C. Craig Sheriff and A. Warrick's Deputy County Clerk

Due proclamation of the opening of Court having been made three times at the door by the sheriff the following business was then had

Now at this time was presented a petition praying for the location of a County road beginning one mile and a half west of Union Town running south three hundred yards thence westerly one half a mile thence on the nearest and best ground to intersect the County road running from La Grande to the Ladd Hill. The Court ordered the Petition read as provided for in the code which was done

Now at this time was presented a petition praying for the vacation of a portion of a County road recently established and running from La Grande to Summerville to commence at C. Street near the dwelling house of S. D. Reinhardt thence North to the N. E. corner of D. Chaplins land claim thence E. 20 chains thence North to the point where the road leading from La Grande to Summerville intersects the same on W. W. Bakers east line. also commencing at the south end of the lane at Probstels North to the Bluff. Mr Robert Palmer James McDonald and Geo N. Clark were chosen as viewers to Meet at La Grande the 16<sup>th</sup> day of March 1867  
D. Chaplin was appointed surveyor

W. Bakers claim thence N. 34.81 intersect the road leading from La Grande to Summerville at the 1/4 Post on W. W. Bakers farm & line.  
Then commencing again on the N side of Grande
