In the matter of Road }  
Supervisor of Road District No. 4 }

On this day is presented the resignation of E. P. McDaniel Supervisor of Road District No. 4, which resignation is accepted and L. R. Holmes is hereby appointed Supervisor of said District.

In the matter of Appropriation }  
on County Road }

Now at this time comes on to be heard the petition of S. Neville and many other citizens of Union County asking for an appropriation of seven hundred dollars to be used in building culverts and improving the grade across the bottom on what is known as the Summerhill and Hendershott Point County Road. And it appearing to the Court that said road is in bad condition and that the road work in the Road District is inadequate to construct the necessary improvements and the urgent necessity that this road should be in a condition to be travelled at all times of the year It is therefore ordered that an appropriation of \$700.00 be made out of the County funds of this County to build culverts and improve the grade across the bottom on said County road. And it is further ordered that

L. R. Holmes is hereby appointed to superintend said improvements and that upon the certificate of said Superintendent that labor has been performed by the parties named in his certificate and filed with the Clerk of this Court he shall issue warrants upon the County Treasurer for the amounts specified in said certificate not in the aggregate to exceed the amount hereby appropriated.
