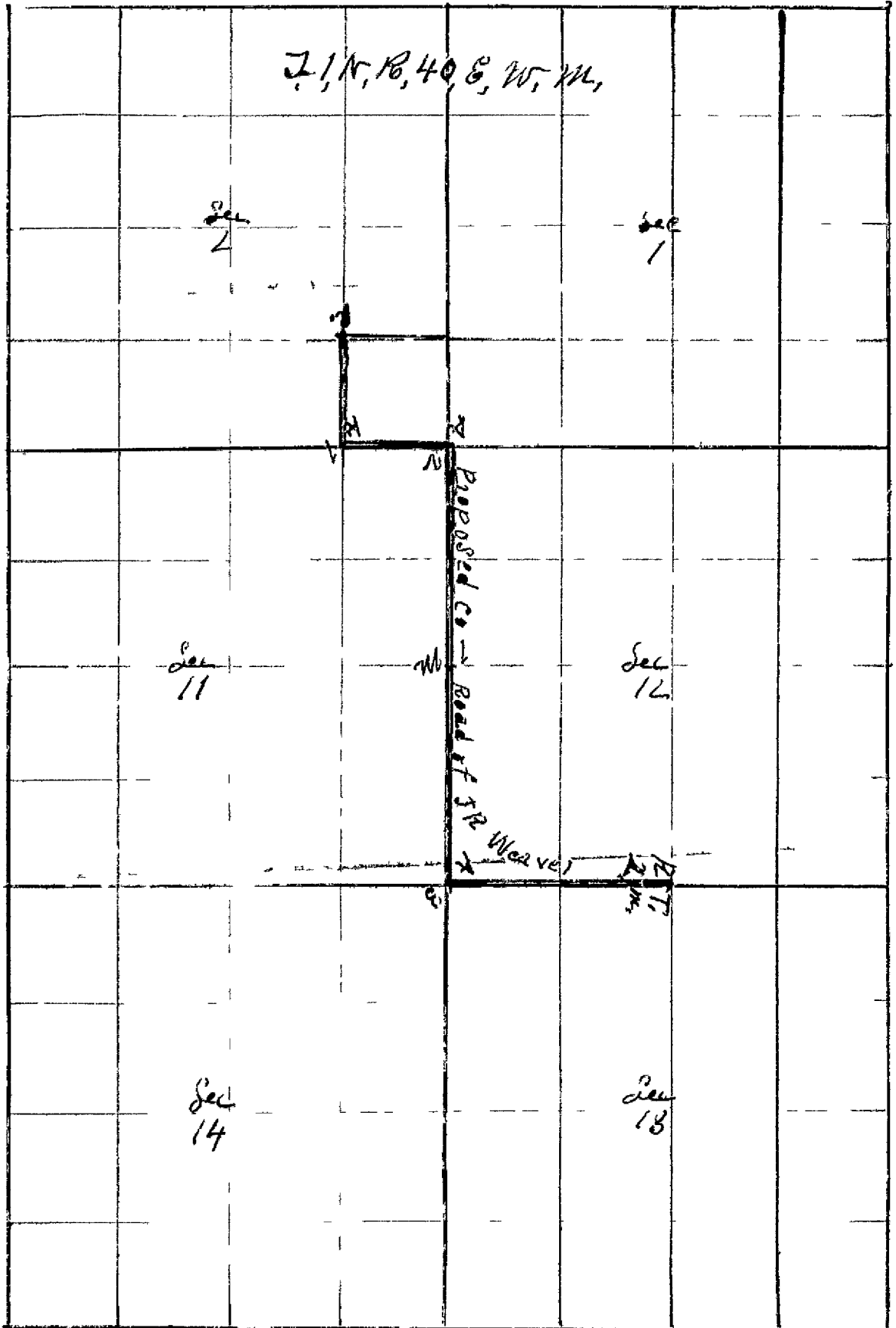

It appearing to the Court that by an act of the Legislature of the State of Oregon entitled "An Act to Provide for the Publication of a Report of the County Finances Approved February 14th 1887, to aid the County Clerk in making the report Section 6 of said act provides that "It shall be the duty of the Justices of the peace in each County to report to the County treasurer once in each month the amount of all fines collected by them, from whom collected and what the fine was for, and at the same time pay to the County Treasurer in money the full amount of said fines collected. If said Justices of the Peace have collected no fines, then they shall report that fact to the County treasurer." And it appearing to the Court that only a few of the Justices of the Peace have been complying with said Statute.
