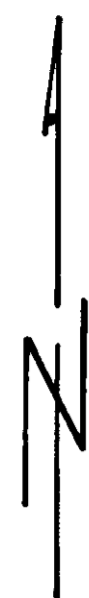

I, James G. Voelz, certify that I am a registered land surveyor in the State of Oregon and have surveyed the land as shown on the accompanying plat. The initial point of the survey is designated by a two inch galvanized iron pipe thirty six inches long and driven six inches below surface of ground. The said initial point of beginning being N0° 11' E 964.4 ft; thence S89° 52' 51" E 30 ft to the true point of beginning; said true point of beginning being determined from the section corner common to Sections 8, 9, 16, and 17, T3S, R38E WM.; From said truepoint of beginning so found and determined, run S89° 52' 51" E 745.8 ft. more or less, to the west line of land conveyed to United States of America (Bonneville Power property) by deed recorded in book 125 page 481, deed records of Union County, Oregon; thence S0° 11' W along the west line of said property of United States of America, 584 ft to the NE corner of land conveyed to James E. Freeman by deed recorded in book 142 page 585 of said county; thence N89° 52' 51" W along north line of said Freeman property 745.8 feet; thence N0° 11' E 584 ft. to the point of beginning. All monuments were placed at corners as required in ORS 92.060

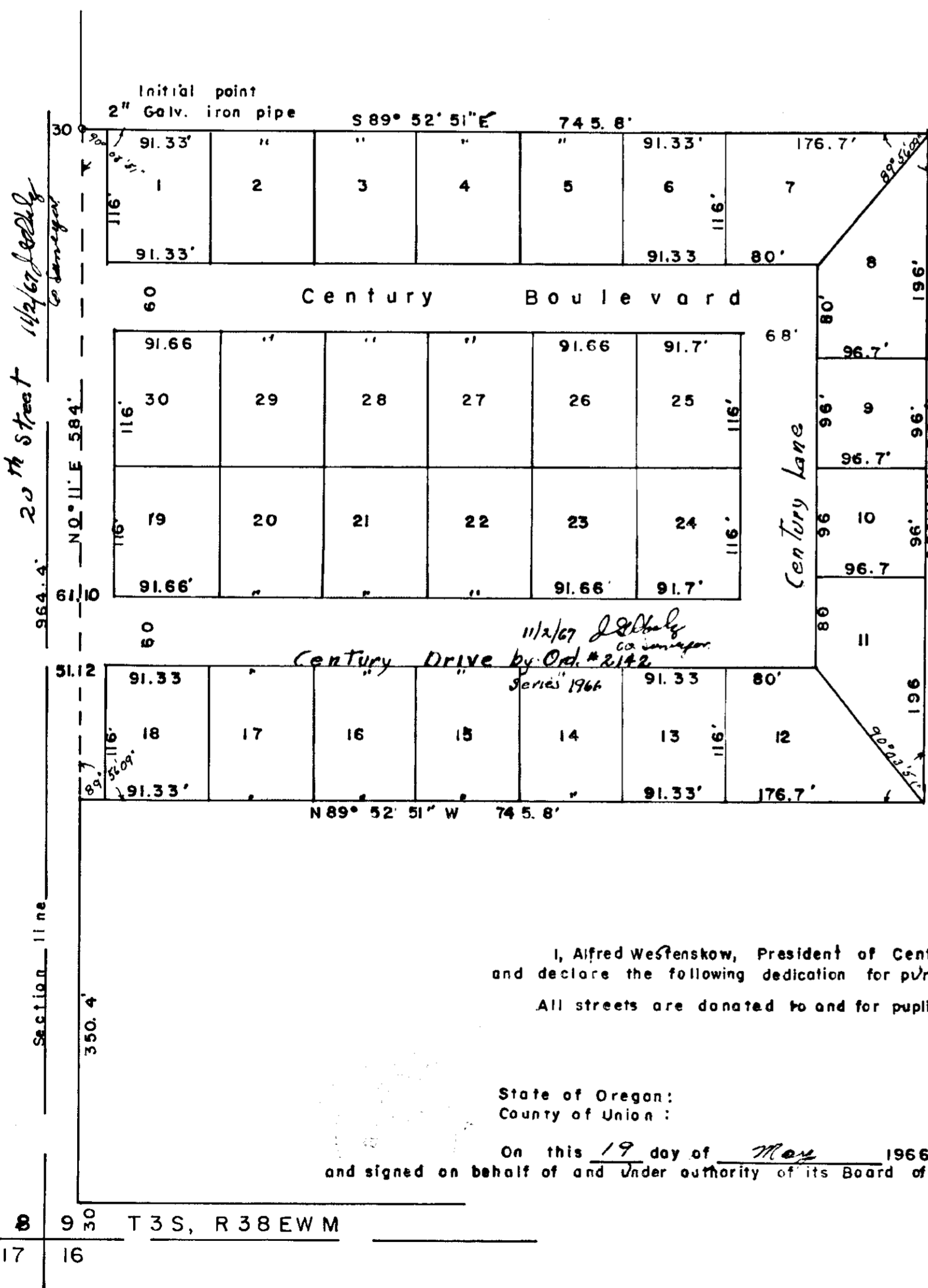
