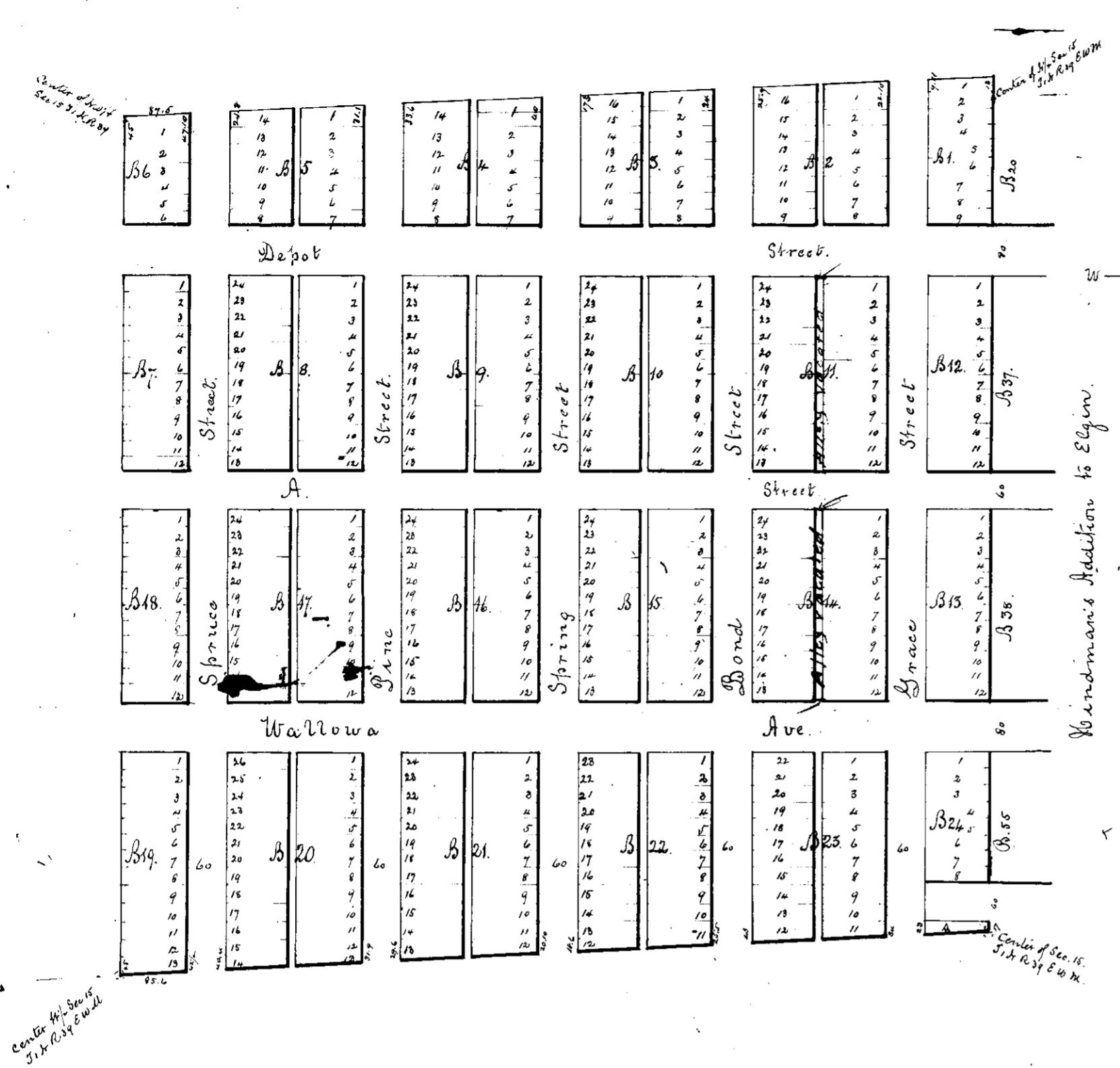


NORTH ELGIN.

Know all Men by these presents that the Union Real Estate and Mining Exchange a corporation duly incorporated and existing under the laws of the State of Oregon and whose principal office and place of business is at Union in the County of Union and State of Oregon being the owner of the land platted by said Corporation described as follows, to-wit: Commencing at a point on the quarter section line 372 feet west of the center of section 15 S. 1. N. R. 39 E. W. 11. thence north 1350 feet thence West to the subdivision line at a point 1350 feet north of the center of the West half of Sec 15 S. 1. N. R. 39 E. W. 11. thence south on said subdivision line to 2nd center of West half of Sec 15 aforesaid, thence East to the subdivision line to the place of beginning, have caused said grounds to be laid out & platted as part of the town of North Elgin Union Co. Oregon as shown on this Plat and the said Corporation does hereby dedicate in lands marked streets and alleys in its portion of said plat to public use forever.
