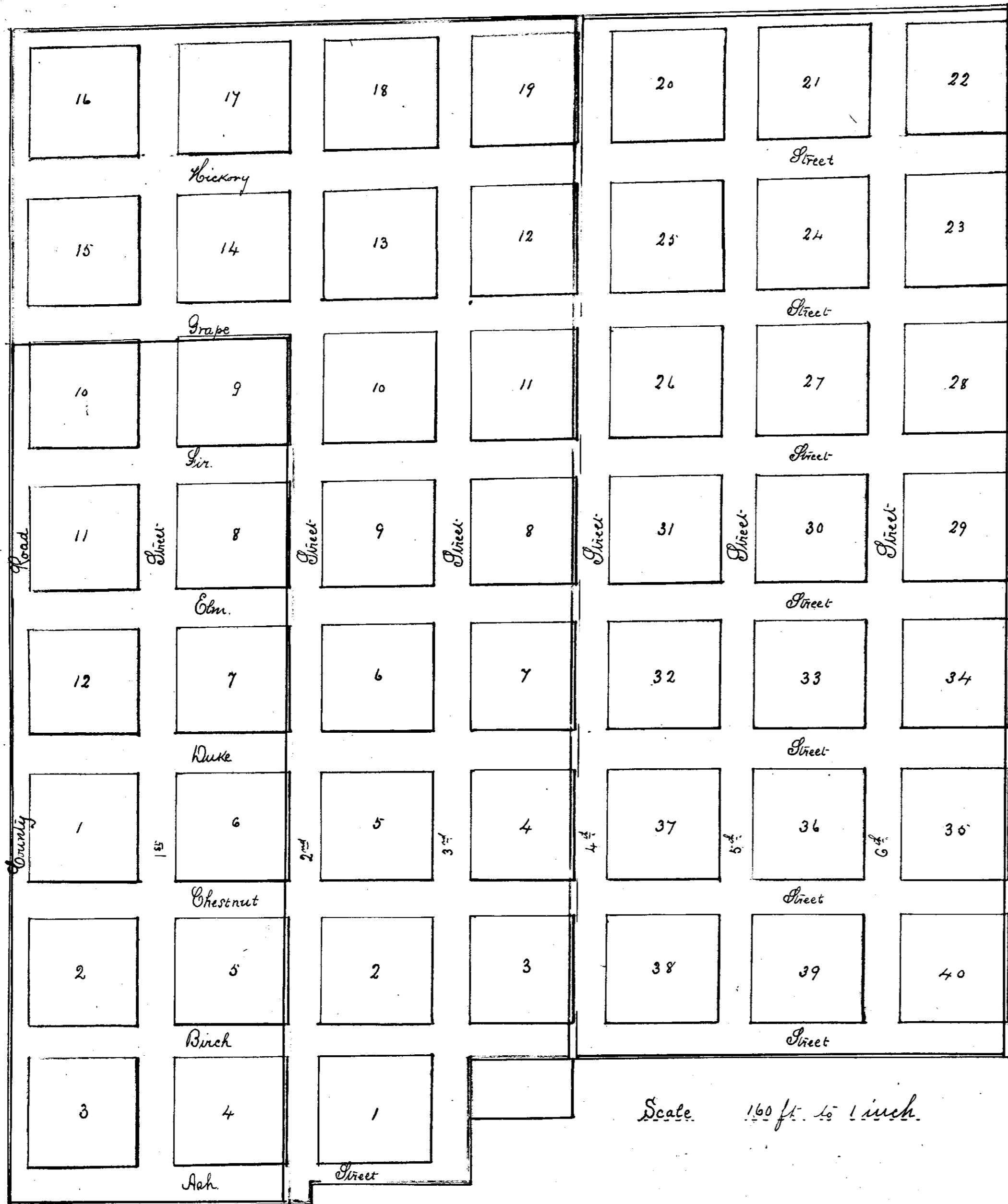

We J. O. Swackhamer and Clara C. Swackhamer his wife being the owners in fee of the following described lands situated lying and being within the corporate limits of the City of Union Union County Oregon viz Commencing at a post set by C. M. Foster Surveyor 1010 feet East and 20 feet South of a certain Rock marked 'R.S.' said rock being the North West Corner of the North East Quarter of the South West Quarter of Section 18 in T. 4 S. R. 40 W. M. running thence South 1920 feet; thence East 400 feet; thence North 1820 feet; thence West 700 feet to the place of beginning. That under the Statute of the State of Oregon we have caused the same to be surveyed & laid out in Blocks as an Addition to the City of Union aforesaid to be known as Swackhamer 2<sup>nd</sup> Addition to the Town of North Union. All Blocks are 200 ft square, and are numbered from 20 to 40 inclusive. Block No. 20, being 60 feet East of the initial point. All Streets are 60 feet wide, and the Blocks are numbered as indicated on this plat which we declare to be a correct plat of said addition, showing its location as connected with our first Addition and McQuillys Addition. And we do hereby dedicate all streets shown on this plat to public use and hold forever.
